One Energy is making preparations to go public via a reverse merger with a SPAC in Q2 2024, with rapid growth expected thereafter.

2 | MAJOR DUTIES AND RESPONSIBILITIES:

- Collaborate with the VP, Corporate Controller to oversee various financial functions, including consolidation, audits, technical accounting, project accounting, intercompany transactions including intercompany financing, and other critical projects.
- Administration of the company's equity plans, including accounting entries, cap table, working with outside vendor to ensure all equity grants are appropriately administered.
- Proactively monitor, research, and analyze accounting literature and regulatory financial reporting trends, developments, and mandates to ensure timely compliance. Implement new accounting standards and company policies. Prepare whitepapers documenting the company's position on various accounting topics.
